Report Summary

Social distancing is a critical practice that is essential to help prevent COVID-19 from spreading. The best way to practice social distancing is to avoid public places and to maintain a distance of at least six feet between you and others. In addition, practice frequent handwashing and cleaning of commonly-touched surfaces. If you are sick or have symptoms such as cough, fever and shortness of breath, call your medical provider. Lincoln Police responded to 950 incidents for the month and 87 case reports were written for the month. Officers responded to 29 vehicle crashes. Patrol officers wrote 55 citations and 38 warnings for the month, along with 1 City Ordinance Citation and 3 City Cannabis Ordinance Citation.

Of the 48 arrests for the month, officers arrested several for warrants, domestic battery, driving while suspended/revoked and Unlawful Possession of Controlled Substance. Detectives continued investigations on 21 cases including participating in CIEG task force operations.

The K9 unit had 6 deployments for the month of June. Out of those deployments, Officer Sullivan and ACE made 3 arrest and had 6 indications. The items indicated were drugs, currency and a firearm.

DARE has been able to provide children with bicycles. Graue Chevrolet has decided to refurbish old bicycles and donate them to children of the community. Officer Fruge is helping out in the distribution aspect.

Our two SRO officers have been patrolling the streets to help their fellow officers with the influx of calls of service and helping the Detectives on follow up for investigations due to COVID-19 and summer break for the schools.

There were 29 crashes the Lincoln Police Department responded to for the month of June.




Uniform Crime Reporting (UCR)


UCR Report for June 2020

Drug Crime Arrests







DIVISION REPORTS

Criminal Investigations

The detectives of the Criminal Investigation Division of the Lincoln Police Department conducted further investigation on 21 active criminal investigations in the month of June. The types of investigations are listed but due to the sensitivity of those investigations, specific information is not available to for release.

- (6) Investigations were narcotics related.
- (5) Investigations involved sexual offenses.
- (8) Investigations involved crimes against persons.
- (2) Investigations were property related.
- (1) Search warrants were executed to further the above investigations.
- Two officers of the Criminal Investigations Division continued to participate in a multi-jurisdictional drug task force, conducting joint investigations with other local, state, and federal agencies.

DARE/Community Policing

Chris Graue, from Graue Chevrolet, is working with Officer Christy Fruge with helping the community by having his service department repairing bicycles to give back to children in the community. The mechanics are repairing, replacing parts and painting bicycles that have been donated by people, due to the bicycles being old and/or needing repair. Graue then contacts Officer Fruge to distribute the bicycles to children in the community, with guidance from local teachers and school resource officers.

Lincoln K9

Officer Sullivan and K9 Ace had 6 deployments for the month of June. The deployments resulted in 3 arrest and 6 indications. The indications were drugs, being cannabis and heroin, currency and a firearm.
